

## Professional Licensure General Disclosure Juris Doctor

In accordance with 34 C.F.R. §668.43, and in compliance with the requirements outlined in the State Authorization Reciprocity Agreements (SARA) Manual, DePaul University provides the following disclosure related to the educational requirements for professional licensure and certification<sup>1</sup>.

This disclosure is strictly limited to the University's determination of whether its educational program, *Juris Doctor*, if successfully completed, would be sufficient to meet the educational licensure or certification requirements in a State for a licensed attorney.<sup>2</sup> DePaul cannot provide verification of an individual's ability to meet licensure or certification requirements unrelated to its educational programming.
