

## Professional Licensure General Disclosure MA in Counseling, School Counseling

In accordance with 34 C.F.R. §668.43, and in compliance with the requirements outlined in the State Authorization Reciprocity Agreements (SARA) Manual, DePaul University provides the following disclosure related to the educational requirements for professional licensure and certification<sup>1</sup>.
