## **Professional Licensure General Disclosure**

## **Programs in Nursing**

DePaul's Bachelor of Science in Nursing (BSN), Masters Entry to Nursing Practice (MENP), Master of Science in Nursing (MSN), and Doctor of Nursing Practice (DNP), whether delivered in person or online, are all accredited by Commission on Collegiate Nursing Education, ensuring that our programs meet national standards.

For face-to-face programs, DePaul's Nursing degrees satisfy the educational portion of licensure in each state, as our students must pass the national NCLEX test. Please check with the state in which you are seeking licensure for any additional requirements.

For online programs, DePaul is approved by Illinois to participate in the National Council for State Authorization and Reciprocity Agreements. NC-SARA is a voluntary, regional approach to state oversight of postsecondary distance education. As a participating institution, DePaul may offer online programming to students in other SARA member states without seeking authorization in that state.

The US Department of Education requires that any institution offering distance education programs to students outside of its home state must acquire authorization from the states in which students reside. Regulations vary from state to state.
